Dear Prosecutor Khan KC,

My name is Roger Philip Foley of Canada. I am an individual sending information to the Office of the Prosecutor (OTP) regarding alleged crimes falling under the jurisdiction of the International Criminal Court (ICC).

I am submitting communications and claims under Article 15 of the Rome Statute. I am requesting the OTP investigate Crimes Against Humanity and Genocide that Canada has committed against its disabled and elderly populations through their Medical Assistance in Dying (MAiD) regime.

Under the guise of "dying with dignity" and so-called "autonomy" to avoid the burden of helping vulnerable persons live with dignity, the conducts of murder, extermination, severe deprivation of physical liberty, torture, persecution, genocide, and other inhumane acts are being committed by Canada. These conducts by Canada are part of an intentional widespread and systematic attack directed against its disabled and elderly populations (and soon disabled children and babies).

As a person with serious physical disabilities, I have been persecuted, coerced to end my life, neglected, abused, and denied basic necessities of life including food, medicine, and water where I almost died, all as a consequence of Canada's MAiD regime.

There is no recourse for justice in Canada pertaining to the MAiD regime. The Supreme Court, lower courts, Federal Government, Provincial Governments, Senate, judges, police, panels, committees, and medical boards have all been compromised. They all lack impartiality, and have become tools of crimes against humanity, persecution, and genocide. The Canadian Government has even kept updated calculations of the ongoing cost savings that its Assisted Dying regime has created by euthanizing the vulnerable. Efforts to seek justice through all domestic means have been repeatedly ignored, and Canada has also ignored the findings of the United Nations (UN).

The UN Special Rapporteurs have expressed alarm and concern regarding their findings of Canada's MAiD regime violating Persons with Disabilities Right to Life. The UN Special Rapporteurs have also expressed alarm and concern regarding my particular case, and determined that in my case, Canada has violated my rights and have subjected me to torture and cruel, inhuman and degrading treatment and punishment, which has also been corroborated by [REDACTED]

Less than a century ago, the Nazi regime committed Genocide and Crimes Against Humanity towards its disabled populations with their euthanasia program (Aktion T4) under the guise of it being "merciful" and "voluntary" to provide a good death to "life unworthy of life", whose death would be a deliverance for them and liberation from a burden for the rest of humanity. Reich propaganda took great care in framing and softening perceptions of Aktion T4, which established there being no access to recourse for justice in Germany. The Nazi regime which carried out the atrocities by those in positions of power, which also included institutions, the legal and medical establishments, membership to extreme ideological groups such as the Nazi party, by superiors and their "yes" men and women or people suggesting they were just "following orders". The Aktion T4 program led to the Nuremberg trials. As a result of those heinous and despicable acts, the ICC and Rome Statute were established to deter such atrocities. Unfortunately, and most regrettably, I must report to the ICC that Canada is repeating the horrors of history.

Accompanying this submission are UN documents, the [REDACTED], the State's cost savings report, and a Public Interest Evidence video that displays some of the evidence proving these conducts from research I conducted to protect my own life. I would be very willing to assist with testimony as a witness or provide any other assistance deemed necessary.

Please accept this submission and open an investigation, Excellency Khan KC.
